RE: Local Property Management, Inc., dba Clear Choice Restoration ("CCR")

Dear Dale Lotts:

Please be aware that this office represents CCR as legal counsel regarding false and defamatory statements you made in a Google review of CCR earlier this week. You also posted the same on the MN BBB site. Screenshots of these posts are attached.

In your post you falsely allege that my client, CCR, failed to follow lead remedial practices. These accusations are false.

We demand that you remove the Google review and any other similar posts that you have posted on the internet and cease and desist from further defaming and slandering CCR.

Defamation occurs where the defamed party shows that the defaming party made a statement that was false, communicated the false information to a third party, and intended to harm the defamed party's reputation. Richie v. Paramount Pictures Corp., 544 N.W.2d 21, 25 (Minn. 1996).

Defamation by implication occurs when the defaming party links unrelated information with the intention of creating a defamatory implication by omitting facts. <u>Diesen v. Hessburg</u>, 455 N.W.2d 446, 450 (Minn. 1990).

Slanderous statements affecting the defamed party in its business are slanders per se and are actionable without any proof of actual damages. <u>Stuempges v. Parke, Davis & Co., 297 N.W.2d 252, 255 (Minn. 1980).</u>

CCR has a great deal invested in its business reputation within the community. It will spare no effort in defending that reputation. CCR categorically denies any allegation that it failed to follow lead remediation practices.

You are hereby put on notice that, in the event you continue your defamation of CCR, and do not immediately remove social media posts and other defamatory content you made against CCR, they will take all reasonable and appropriate measures, including commencing legal action against you, to defend its good reputation.
